Circle of Excellence: Overview (updated for 2016 qualifying year)

Purpose: To recognize members of the Golden Isles Association of REALTORS® who have excelled in real estate sales and property management during the qualifying period.

Qualifying period: Plaques given in beginning of the next year for the qualifying period of January 1st-December 31st of the current year. (This year's qualifying period earns REALTORS® the award for 2017 Circle of Excellence).

Claiming Credit:

- **Residential & Commercial REALTORS®:** if a listing is 2 sided (listed by one agent, sold by another) each may claim 100%. If co-listed or co-selling agent involved, each may claim 50%. If you are both Listing and Selling agent, 100% is the most allowed to claim.
- **Property Mangers:** if more than one REALTOR® works together with joint management responsibilities, the total gross management fee/commission will be divided equally. Each REALTOR® will be then be required to make \$70,000 in management fees.
- Commercial REALTOR®: If applying using commercial real estate, you can combine commercial sales and commercial leasing. The commercial lease will be calculated during the year in which the lease is fully executed and only that year. The commercial lease will calculate as the gross amount of rents that will be collected over the term of the lease.

Categories:

Circle of Excellence *Member*: REALTOR® who has not made life membership yet. Must make \$3,000,000 in sales and 6 transactions in qualifying year or Property Manager who makes \$70,000 in gross management fees and/or commissions to be considered "active".

Circle of Excellence *Life Member*: REALTOR® or Property Manager who has qualified as an "<u>active</u>" member for either 3 years in a row or after any 5 active years. Once you have reached Life Member, you will be considered a Life status member every year an application is filed, until Oglethorpe status is reached. Please see "maintaining membership" for more details.

Circle of Excellence *Oglethorpe Member*: REALTOR® or Property Manager who has had 10 "active" years in Circle of Excellence. These do not need to be in succession. Once you are an Oglethorpe member, you will be considered Oglethorpe for all years in which an application is filed.

Maintaining Membership: After you have reached Life status, you may remain a Circle of Excellence member, without an "active" qualifying year. An application will still need to be turned in and the \$35 application fee paid for you to remain a member. You will be recognized and still receive a plaque at the Circle of Excellence Luncheon. This will keep you current with the Circle of Excellence Club. If you do not apply for a year or more, there will be a \$35 reinstatement fee along with the application fee. Years in which you were not an "active" member, will not be applied toward Oglethorpe.

Please remember: for REALTORS® the worksheet, adding machine tape and Brokers signature on application are required for the application to be accepted. Property Managers need the total commission on application and Brokers signature on application.
