Grievance Committee

The President shall appoint, subject to the confirmation of the Board of Directors, a Grievance Committee of no less than five members of the Vicksburg-Warren County Board of REALTORS®. Committee members so named shall serve two-year staggered terms. The chairperson shall be selected by the committee or designated by the President. In accepting appointment to the Grievance Committee, members agree to attend required Code of Ethics training during their term.

MLS Committee

The President shall appoint, subject to the confirmation of the Board of Directors, a Multiple Listing Committee of 5 (five) REALTORS® members of who at least 3 must be Participants in Multiple Listing. The committee members so named shall serve two year-staggered terms. The chairperson must be a Participant and shall be selected by the committee or designated by the President.

Executive Nominating Committee for Election of Officers & Directors

Is a Nominating committee of 5 (five) REALTOR® members which include past three active REALTOR® Board Presidents and shall be appointed by the President with the approval of the Board of Directors.

Election Committee

The President, with the approval of the Board of Directors, shall appoint an Election Committee of 3 (three) REALTOR® members to conduct the election.

REALTOR® & REALTOR-ASSOCIATE® of the Year Nominating Committee

The committee will consist of six members, three REALTOR-ASSOCIATE® who received the REALTOR-ASSOCIATE® of the Year Award in the previous three previous years and three REALTORS® who received the REALTOR® of the Year Award in the previous three years. The chairman position will be held by the most tenured REALTOR®, if the most tenured REALTOR® declines the position or is unable to fulfill the chairman duties, the committee shall nominate a chairman among its members.

MLS Sub-Committee (Publication Committee REMP)

This committee is a Sub-Committee of the MLS Committee, consisting of a Chairman and 2 other members, elected by vote of the Principals. The Chairman and each member of the committee must be a Principal status AND must be advertisers in the publications. All members will voluntarily serve for at least a 3-year period, with only 1 new member replaced each year. Members of the sub-committee may voluntarily serve indefinite periods if so voted by the Principals. *(The chairman will be elected for a 3 year term and 1 member for a 2 year term, and the third member for a 1 year term initially).*
