Contributions will be split 25% to RIAC (a fund to support issues) and 5% to RPAC, which will be further divided as described below. 70% of each RPAC contribution is used by Georgia RPAC to support state and local political candidates. 30% of the balance is sent to National RPAC to support federal candidates and is charged against your limits under 2 U.S.C 441A; 65% of the NAR RPAC contributions are used for other federal grassroots political activities. Contributions are not deductible as charitable contributions for federal income tax purposes. You are strongly advised to contact your tax advisor regarding this and all tax related matters.
