Orientation

To be inducted into WCAR, new members must complete a one day orientation at the Wilkes Chamber of Commerce from 8:45am - 4:30pm (MLS Only members from 10am - 11am). Orientation offered on:

All upcoming broker members are required to complete the Code of Ethics class online at www.Realtor.org prior to Orientation. New brokers will need their NAR membership ID# in order to take this class.
