

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to [www.cameronclement.com](http://www.cameronclement.com) and Cameron Clement and governs data collection and usage. ## Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Cameron Clement may collect personally identifiable information, such as your:

## Sharing Information with Third Parties
