REQUIREMENTS FOR MLS ACCESS:
<ul> <li>In electing to access the MLBOR MLS, I understand that I must hold a valid NC real estate or appraiser license and must either be a Designated REALTOR® (DR) or Broker-in-Charge (BIC) of a firm or remain affiliated with a supervising DR/BIC who also either holds membership or MLS Only Access with MLBOR.</li> <li>I agree that I will keep the login name and password for my MLS access confidential and that I will not disclose them to ANY other person, including another Broker in my firm. (Personal Assistants who might require access to your listings will be assigned their own unique access to your account. Please contact our office for this free assignment). Breach of this Non-disclosure obligation may result in termination of my MLS privileges.</li> <li>The Certificate for NON-Use WAIVER must be completed and signed by the DR/BIC.</li> <li>NC forms through Zipforms are free only to "members". MLS Only is a Non-member position.</li> <li>I am responsible for reading and staying updated with the MLS Rules and Regulations (available in the MLS).</li> <li>I agree to make prompt payment of all MLS related fees and charges. All invoices will be posted within the MLS system and are to be paid online by credit/debit card or bank routing number &amp; account number. A \$30 late fee is automatically applied after the due date. All late fee funds are applied to our scholarship fundraising.</li> </ul>
MLBOR maintains a Data Sharing agreement with Carolina Smokies Association of REALTORS® so that their listings can be <i>VIEWED ONLY</i> from our MLS and vice versa.
