



2019 Mountain Lakes Scholarship

\$1000 scholarship/s will be awarded to graduating high school student/s from Cherokee, Clay or Graham County, NC. This scholarship is available to students who demonstrate academic strength, leadership, community involvement, and financial need. Scholarships are for tuition and/or books and have no cash exchange value and are non-transferable.

Criteria for Eligibility

To be eligible for considerations, applicants must submit a completed application and all supporting documents to the **Scholarship Committee** postmarked no later than **April 15th**. Mailed to **Mountain Lakes Board of REALTORS, 93 Tennessee St., Murphy, NC 28906**. Or you can drop it off at the office M-F, between 8:30-4:00.

Applicant must be a US citizen and a North Carolina Resident
Applicant must be a graduating senior with a 2.85 GPA or above
Applicant must plan to attend a two or a four year college, university, or community college as a full time student in the fall of 2019.

This is an academic/need based scholarship. Precedence can be given to those with greater need.

The Award presentation will be at the Senior Awards Ceremony.

The Award will be paid directly to the school of choice with instructions to disperse \$500 for first semester/quarter and \$500 to the second semester/quarter.

Application Procedures Checklist

To be considered each applicant must submit **ALL** of the following:

- Completed **application**
- **Two letters of recommendation**. One from a faculty member. One from a non-related adult.
- Copy of high **school transcript** through present date and a copy of their **SAT official report of scores**. If not available explain why.
- Completed **personal essay** stating your qualifications, including personal background, leadership, educational and personal goals, special contributions, and volunteer work at school and in the community and career interests. (See Essay Section IV)
- Copy of the requested Tax return

This application and the essay are to be completed by the STUDENT. Any submissions deemed to be completed by another person will not be considered for the award.
