The City of Springfield has released its 2021 Community Development Block Grant (CDBG) Request for Proposals. The application packet is available online: <a href="https://www.springfield-or.gov/city/development-public-works/housing-and-block-grant-programs/">https://www.springfield-or.gov/city/development-public-works/housing-and-block-grant-programs/</a>

Springfield has approximately \$400,000 in federal Community Development Block Grant (CDBG) funds available to award to projects. The City requests proposals from public agencies, non-profit organizations, and private developers in order to address housing and community development needs in our community primarily for low-income households.

Funds are available through the federal Community Development Block Grant (CDBG) program under the U.S. Department of Housing and Urban Development (HUD). The program is administered at the local level by City staff, though subject to federal regulations (24 CFR Part 570).

All funds referenced in this Request for Proposals will be available after July 1, 2021 for use in Fiscal Year 2022 (July 1, 2021 – June 30, 2022). Some portion of funds may not be available until Fall 2021.

Applications are due by March 15, 2021.


