approved I agree as a condition to membership to complete the indoctrination course (New Member
Orientation) of the Valdosta Board of REALTORS®, and otherwise on my own initiative to thoroughly
familiarize myself with the Code of Ethics of the NATIONAL ASSOCIATION OF REALTORS®, including
the duty to arbitrate business disputes in accordance with the Code of Ethics and Arbitration Manual of the board,
and the constitution, bylaws, and rules and regulations of the above named board, the Georgia Association of
REALTORS®, and the National Association of REALTORS®. I further agree that my act of paying dues shall
evidence my initial and continuing commitment to abide by the aforementioned Code of Ethics, constitution,
bylaws, rules and regulations, and duty to arbitrate, all as from time to time amended. Finally, I consent and
authorize the board, through its membership committee or otherwise, to invite and receive information and
comment about me from any member or other person, and I agree that any information and comment furnished to
the board by any member or other person in response to any such invitation shall be conclusively deemed to be

SOUTH GEORGIA MLS DATABASE AGREEMENT

THIS AGREEMENT, made and entered into this day of,20, between South
Georgia MLS, a Georgia corporation hereinafter referred to as "MLS," and,
hereinafter referred to as "Salesperson," whose license is placed with,
Principal/Broker/Appraiser/Owner,(Firm).
WITNESSETH:
It is understood between the parties hereto that said assigned database password and <i>lock box key</i> are of
vital importance to the security of the Multiple Listing Service and should said password or <i>lock box key</i> come in
the possession of any other person, irreparable damage to the MLS will result. Therefore, Salesperson covenants and agrees that (1) he will take all reasonable care to protect said password from being known that (2) he will no
and agrees that (1) he will take all reasonable care to protect said password from being known; that (2) he will no permit said password to be used by any other person; that (3) he will immediately report to MLS any attempt by
anyone to utilize password; that (4) in the event Salesperson's license becomes inactive, suspended, or revoked for
any reason, Salesperson shall immediately notify MLS.
A fine of up to \$5,000.00 shall be imposed on Salesperson for misuse of said database password or lock box ke
The term "Salesperson" shall mean the person receiving a lock box key and/or database password from
MLS and shall include the terms "Appraiser", "Salesman," "Saleswoman," "Associate Broker," and "Broker."
Should Salesperson either for himself or in conjunction with other persons willfully permit said
password or <i>lock box key</i> to be used by any other person during the term of this agreement, same shall be deemed
a violation of this agreement and Salesperson shall be liable to MLS for all expenses necessary to re-establish its
lock box and/or database security, as well as any other loss or damage that might result to MLS there from. Also note that No one shall be required to lease a lock box key except on a voluntary basis.
IN WITNESS WHEREOF, MLS has caused this agreement to be executed by its appropriate officer, or
designated agents, and Salesperson has executed this agreement this day and year first above written.
I hereby apply for Principal membership in the South Georgia MLS (MLS) and agree to a one time non-refundable Initial Participation Fee of Two Thousand dollars (\$2,000.00) (or two (2) monthly payments of one thousand dollars (\$1,000.00), an application fee of \$150.00 plus quarterly fees which I understand will be returned to me in the event I am not accepted to membership. I agree as a condition of membership in the MLS to abide by all relevant rules and regulations and other obligations of participation, including payment of monthly fees. I will on my own initiative thoroughly familiarize myself with the South Georgia MLS Bylaws and Rules & Regulations. I further agree that my act of paying dues shall evidence my initial and continuing commitment to abide by the aforementioned <i>Rules and Regulations</i> as from time to time amended.
I further agree to be bound by the MLS Standards of Conduct, and if a REALTOR® Member, with the NAR Code of Ethics as established in the NAR Code of Ethics and Arbitration Manual, including the obligation to submit to ethics hearings and the duty to arbitrate contractual disputes with other REALTORS® in accordance with the established procedures of the board. I understand that a violation of the Code of Ethics, if applicable, or MLS Rules and Regulations may result in suspension or termination of MLS rights and privileges and that I may be assessed an administrative processing fee not to exceed \$500 which may in addition to any discipline, including fines, that may be imposed.
I acknowledge and agree that within 180 days from the date this application is approved, that I will attend offered MLS Rules and Regulations training and MLS computer software training. In the event I fail to attend MLS Computer software training, without a written excused absence from the South Georgia MLS, that me
membership will be suspended until the requirement is met.
